ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS is entered into this 13th day of December, 2017 by and between TSX Inc., a corporation organized under the Business Corporations Act (Ontario) (“TSX”) and Natural Gas Exchange Inc., a corporation organized under the Business Corporations Act (Canada) (“NGX”).

WHEREAS, TSX is the owner of the trademark applications and/or registrations identified on Schedule A attached hereto, including the goodwill of the business connected with the use of, and symbolized by, said marks; and

WHEREAS, TSX’s parent company, TMX Group Inc., along with Shorcan Brokers Limited, TMX Group Limited and Intercontinental Exchange, Inc., entered into that certain Stock Purchase Agreement, dated as of October 27, 2017 (the “Purchase Agreement”), pursuant to which TMX Group Inc. agreed to cause TSX to validly and effectively assign, at no cost, all right, title and interest in and to the Transferred Trademarks (defined below) to NGX.

NOW THEREFORE, the parties hereto hereby agree as follows:


1. For good and valuable consideration, including the promises and covenants set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, TSX hereby assigns and transfers to NGX the entire right, title and interest in and to the trademark applications and registrations identified on Schedule A and the trademarks which are the subject thereof (the “Transferred Trademarks”), including the goodwill of the business connected with the use of, and symbolized by, said marks and all rights therein provided by international conventions and treaties, all rights of priority and renewals and the right to recover for past, present and future infringement, dilution, misappropriation, unlawful imitation or other violation thereof or conflict therewith.
2. TSX further agrees, for itself, its successors and assigns, to timely execute and deliver, at TSX’s sole expense, such further documents and to perform such further lawful acts as may reasonably be requested by NGX, to effectuate this assignment or as may be necessary or desirable to assist NGX (or its successors, assigns or legal representatives) in the implementation, recordation or perfection of this assignment and NGX’s interest in and to the Transferred Trademarks.
3. TSX shall not enter into any agreement in conflict with this agreement.
4. TSX hereby authorizes and requests any official of any applicable governmental authority to issue any and all registrations from any and all applications for registration included in the Transferred Trademarks to and in the name of NGX.
5. This assignment shall be governed by and construed in accordance with the laws of the Province of Alberta and the laws of Canada applicable therein, and the parties hereby irrevocably submit to the non-exclusive jurisdiction of the courts of Alberta.
6. This assignment may be executed and delivered (including by facsimile transmission) in one or more counterparts, and by the different parties hereto in separate counterparts,

each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement.


