**CERTIFICATE OF MERGER OF
BLING NATION, LTD.
(a company organized under the laws of Bermuda)
WITH AND INTO
LEMON, INC.
(a Delaware corporation)**


Pursuant to Section 252 of the
General Corporation Law of the State of Delaware

Lemon, Inc., a Delaware corporation ("*Lemon*"), does hereby certify to the following facts relating to the merger (the "*Merger*") of Bling Nation, Ltd., a company organized under the laws of Bermuda ("*Bling Nation*"), with and into Lemon, with Lemon remaining as the surviving corporation of the Merger (the "*Surviving Corporation*");

- FIRST: Lemon is incorporated pursuant to the General Corporation Law of the State of Delaware ("*DGCL*"). Bling Nation is organized under the Bermuda Companies Act 1981, as amended. Lemon and Bling Nation are the constituent corporations in the Merger.
- SECOND: An Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by Lemon and Bling Nation in accordance with the provisions of Section 252(c) of the DGCL.
- THIRD: The name of the Surviving Corporation shall be Lemon, Inc.
- FOURTH: Upon the effectiveness of the Merger, the certificate of incorporation of the Surviving Corporation shall be amended and restated in its entirety to provide as set forth in Exhibit A attached hereto.
- FIFTH: The executed Agreement and Plan of Merger is on file at the principal place of business of Lemon, the Surviving Corporation, 364 University Avenue, Palo Alto, California 94301.
- SIXTH: A copy of the executed Agreement and Plan of Merger will be furnished by Lemon, the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation of the Merger.
- SEVENTH: The authorized share capital of Bling Nation is US\$37,128,532 divided into 22,000,000 common shares of US\$0.001 par value and 15,128,532 preferred shares of US\$0.001 par value each.
- EIGHTH: The Merger shall become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

IN WITNESS WHEREOF, Lemon has caused this Certificate of Merger to be executed by its duly authorized officer as of March 19, 2012.
