ASSIGNMENT

THIS ASSIGNMENT is made the 1st day of April Two Thousand and Eight (2008)

BETWEEN

3. The Assignor also covenants that the Assignee shall have the right to take all necessary action to defend any opposition proceedings to these applications and the Assignor shall lend his name and do all things within his power to promote the success of such action.


