TWO: Article I of the Amended and Restated Articles of Incorporation of this corporation is hereby amended to read as follows:

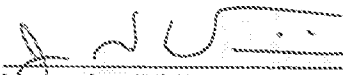
*The name of this corporation is Evalytica, Inc. (the "Corporation").*

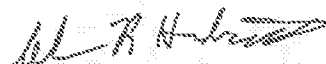
