## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Assignment") is made and entered into, effective as of February 28, 2018 (the "Effective Date"), by and between **PENTAIR WATER GROUP, INC.**, a Delaware corporation with a principal address of 5500 Wayzata Boulevard, Suite 800, Golden Valley, Minnesota, 55416 ("Assignor"), and **PENTAIR WATER POOL AND SPA, INC.**, a Delaware corporation with a principal address of 400 Regency Forest Drive, Suite 300, Cary, North Carolina, 27518 ("Assignee"; together with Assignor, the "Parties").

**WHEREAS**, Assignor is the owner of all right, title, and interest in and to the trademark specified on Exhibit A, attached hereto and incorporated herein by reference, and the registration therefor, as further specified on Exhibit A (the "Trademark");


**WHEREAS**, Assignor desires to contribute, transfer, and assign all right, title, and interest in and to the Trademark and the goodwill associated therewith to Assignee, and Assignee desires to receive same;

**NOW THEREFORE**, in consideration of the mutual covenants and promises of the Parties, and in exchange for good and valuable consideration the receipt and sufficiency of which the Parties hereby acknowledge, the Parties agree as follows:

1. Assignor hereby contributes, transfers, and assigns to Assignee: (i) all right, title, and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark and in connection with which the Trademark is used; and (ii) the registration for the Trademark as set forth on Exhibit A hereto; and (iii) the full right to sue for, obtain all remedies for, and recover all profits and damages recoverable from past, ongoing, current, and/or future infringements of the Trademark.
2. All of the foregoing shall be held and enjoyed by Assignee, for its own benefit and for the benefit of its successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.
3. Assignor agrees to cooperate with Assignee in the recordal of this Assignment with the relevant trademark office in the relevant jurisdiction, and to execute any and all documents that are necessary to accomplish such recordal.


