**RELEASE OF PATENT AND TRADEMARK SECURITY INTEREST**

THIS RELEASE OF PATENT AND TRADEMARK SECURITY INTEREST is made as of March 12, 2018, by DEERPATH CAPITAL II, LP, a Delaware limited partnership, in its capacity as administrative agent and collateral agent for itself and certain other lenders (the “Secured Party”), for the benefit of OMEGA FINANCIAL, LLC, a Delaware limited liability company (the “Debtor”).


