TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is made this 9th day of March 2018 (the "Effective Date"), by and between ML Fashion, LLC, a Delaware limited liability company ("Assignor"), and Threads of Privilege, LLC, a Delaware limited liability company ("Assignee").

WHEREAS, Assignor owns all rights and interest in and to the trademark THREADS OF PRIVILEGE, including but not limited to U.S. Trademark Reg. No. 87767874 (the "Mark");

WHEREAS, Assignor wishes to assign all rights and interest in and to the Mark, and that part of the goodwill of Assignor's business connected with the use of and symbolized by the Mark, to Assignee.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties agree as follows:


1. The recitals stated above are hereby incorporated herein and shall have binding and interpretive effect.

2. Assignor does hereby assign, convey and transfer to Assignee, its successors, assigns and legal representatives, the full and entire right and interest in and to the following property:

- (i) the Mark;
- (ii) that part of the goodwill of Assignor's business connected with the use of and symbolized by the Mark;
- (iii) all of Assignor's trademark rights in the Mark under the laws of any jurisdiction, including all rights granted under 15 U.S.C. §1051, *et. seq.*, all rights granted under the statutes of any other jurisdiction, and all rights granted under the common laws of any jurisdiction (collectively, the "Trademark Rights");
- (iv) the right to claim the Trademark Rights and to obtain registrations therefor in the sole name of Assignee under the trademark laws of any jurisdiction; and
- (v) all causes of action for, and claims for damages by reason of, any infringement of the Trademark Rights in any jurisdiction, which causes of action and claims arose prior to the date of execution hereof.

IN WITNESS WHEREOF, Assignor and Assignee have caused this instrument to be executed on the date first indicated above.


