# TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Assignment") is entered into as of March 23, 2018, by and between, Strayhan Investments Inc., a California corporation DBA Rubicon Brewing Company, whose address is 2004 Capitol Avenue, Sacramento, California 95811 ("Assignor"), and Rubicon Brewing Company, LLC, a Wyoming limited liability company, whose address is 30 N. Gould Street, Suite R, Sheridan, Wyoming 82801 ("Assignee"). The parties agree as follows:

1. Background. Assignor is a party to a certain Security Agreement in favor of Exchange Bank ("Secured Creditor") which was recorded in the United States Patent and Trademark Office on December 13, 2017 at Reel/Frame No. 6227/0752 with respect to the trademark MONKEY KNIFE FIGHT (U.S. Serial. No. 86543458) (the "Mark"), pursuant to which Secured Creditor has a continuing security interest in and lien on the Marks and the Secured Creditor is granted an irrevocable power of attorney for the purpose of executing any documents necessary to perfect, amend, or to continue the security interest granted in the Security Agreement or to demand termination of filings of other secured parties.


The Secured Creditor has foreclosed on its security interest in the Marks and has sold the Marks to Assignee pursuant to a public foreclosure sale. The Secured Creditor now wishes to record the assignment of the Marks to Assignee.

2. Assignment. For valuable consideration, Assignor hereby grants, transfers and assigns to Assignee all of Assignor's right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and the above identified registration and application thereof.

3. Miscellaneous. This Agreement shall (i) be binding on the successors, assigns and licensees of Assignor and Assignee (ii) inure to the benefit of the successors and assigns of Assignee, and (iii) be governed by and construed in accordance with the laws of the State of California.


