**TERMINATION AND RELEASE
OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS) ("Release"), dated as of March 29, 2018, by **WEBSTER BANK, NATIONAL ASSOCIATION**, as administrative agent (the "Administrative Agent"), in favor of **PETROSKILLS, LLC**, an Oklahoma limited liability company (the "Grantor").

WHEREAS, pursuant to the terms of that certain Security Agreement, dated as of November 30, 2012 (as amended supplement or otherwise modified from time to time, the "Agreement"), and that certain Grant of Security Interest (Trademarks) (the "Agreement"), dated as of November 30, 2012, between the Grantor and the Administrative Agent, the Grantor granted to the Administrative Agent a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule A attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (together with the Trademarks, the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement referred to in the Agreement);

WHEREAS, the Administrative Agent wishes to terminate and release its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, including the Trademarks identified on Schedule A attached hereto; and

WHEREAS, the Agreement was filed on December 5, 2012 with the United States Patent and Trademark Office in Reel: 4913; Frame: 0168.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, as granted under the Agreement and the Agreement, and reassigns and transfers to the Grantor all right, title and interest that the Administrative Agent may have in the Collateral, and terminates the Agreement. The Administrative Agent hereby authorizes the Grantor, or the Grantor's authorized representative, to record this Release with the United States Patent and Trademark Office.
