TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this “**Agreement**”) is made as of March 30, 2018 by and between Smartvue Corporation, a Delaware corporation (“**Assignor**”), and Sensormatic Electronics, LLC, a Nevada limited liability company (“**Assignee**”).

WHEREAS, the Assignor has adopted and used and is using in commerce the trademarks set forth in the attached Schedule 1 (the “**Marks**”); and

WHEREAS, Assignor and Assignee have entered into an Intellectual Property Assignment Agreement dated as of March 16, 2018 (the “**Agreement**”) and pursuant to the Agreement, Assignor has agreed to assign to Assignee said Marks and the goodwill associated with such Marks.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby irrevocably conveys, assigns, transfers, sells and delivers to Assignee, its successors and assigns:

(a) all rights, title and interests in and to the Marks, including any renewals of registrations or applications thereof that may be secured under any applicable Law now or hereafter in effect;

(b) all goodwill of any business associated and connected with the Marks or symbolized thereby;

(c) all rights of any kind whatsoever of Assignor accruing under any of the Marks provided by applicable Law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(d) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the Marks; and

(e) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Assignor authorizes and requests the Commissioner of Patent and Trademarks (and any other non-U.S. counterpart) to record Assignee as owner of the Marks, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

3. Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of

attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Marks to Assignee, or any assignee or successor thereto.

4. This Agreement shall be construed in accordance with, and governed in all respects by, the internal laws of the State of Delaware (without giving effect to principles of conflicts of laws).

5. The invalidity or unenforceability of any provision of this Agreement shall in no way affect the validity or enforceability of any other provision of the Assignment. Wherever possible, each provision hereof shall be interpreted in such a manner as to be effective and valid under Law. In case any one or more of the provisions contained herein shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, such provision or provisions shall be ineffective to the extent, but only to the extent, of such invalidity, illegality or unenforceability, without invalidating the remainder of such invalid, illegal or unenforceable provision or provisions or any other provisions hereof, unless such a construction would be unreasonable, and the parties hereto shall negotiate in good faith to modify this Agreement so as to effect the original intent of the parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the greatest extent possible. It is understood that any finding of invalidity of one assignment as effected hereby shall not affect the assignment of other Marks assigned to Assignee hereunder.

6. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.



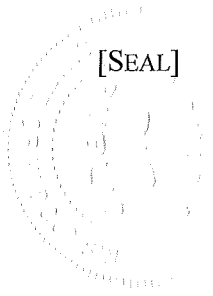
