**RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made effective as of April 30, 2018, by SaaS Capital Funding II, LLC (the "Secured Party") in favor of Reeher LLC, a Minnesota limited liability company (the "Company").

WHEREAS, the Company and the Secured Party are parties to that certain Loan and Security Agreement dated as of March 18, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement") pursuant to which the Secured Party agreed to extend to the Company certain credit accommodations;

WHEREAS, pursuant to the Loan Agreement the Company executed and delivered that certain Patent, Trademark and Copyright Security Agreement dated as of March 18, 2016 (the "IP Security Agreement"), whereby, among other things, the Company granted the Secured Party a security interest in and lien on the trademarks identified on Exhibit A hereto (the "Trademark Collateral");

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office against the Trademark Collateral on March 18, 2016 at Reel number 5753 and Frame number 0620; and

WHEREAS, the Company has satisfied all of the Obligations under the Loan Agreement and the other Loan Documents and has requested that the Secured Party terminate and release its security interests in and liens on the Trademark Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Loan Agreement.

2) Termination and Release of Security Interest. The Secured Party hereby terminates, releases, and discharges its security interest in and liens on the Trademark Collateral, including, without limitation, the trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Company, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such trademarks, effective as of the date set forth above.
