ASSIGNMENT OF TRADEMARKS

WHEREAS, the Assignor is the owner of the U.S. trademark registration filed on February 12, 2010, having the registration number 3,847,785 for the trademark "BURGEROLOGY" made in connection with restaurant services (the "Mark");

WHEREAS, the Assignor desires to convey, transfer, assign, deliver and contributor to Assignee all of its right, title and interest in and to the Mark;

WHEREAS, the Assignor agrees to cooperate, in accordance with the terms of the Trademark Purchase Agreement, as may be necessary to transfer, perfect, and defend the Assignee's ownership of the Mark as may reasonably be requested by the Assignee from time to time at Assignee's sole expense.

NOW, THEREFORE, in consideration of good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign and transfer to Assignee, its successors and assigns, all of Assignee's right, title and interest in said trademark registration together with all of the goodwill of the business in connection with which the Mark is used, and with the full right to sue in law or equity, in order to protect the Mark and the right to recover for any past or future infringement of the Mark and any and all other rights and remedies associated with the use, ownership and registration of the Mark throughout the world.

The Commissioner of Trademarks is hereby requested and authorized to issue any certificates or notifications to the Assignee and to correspond hereinafter with the Assignee's attorneys, Harris Beach PLLC, 333 West Washington Street, Suite 200, Syracuse, New York 13104, regarding any matter related to the prosecution, alteration or amendment of the Mark.
