

(Under Section 904 of the Business Corporation Law)

It is hereby certified, upon and behalf of each of the constituent corporations herein named, as follows:

FIRST: The merger was authorized with respect to each constituent corporation in the following manner: The Board of Directors of each of the constituent corporations has duly adopted by unanimous written consent an agreement and plan of merger setting forth the terms and conditions of the merger of said corporations and such agreement and plan of merger was subsequently approved by the written consent of the sole stockholder of each of the constituent corporations.

SECOND: The name of the domestic constituent corporation, which is to be the surviving corporation and which is hereinafter sometimes referred to as the "surviving constituent corporation," the certificate of incorporation of which was filed by the Department of State on August 27, 1929, is Stantec Consulting Services Inc. The name under which said corporation was formed is Manhasset Civil Engineers Inc.

FIFTH: The number of outstanding shares of the merged constituent corporation consists of 500,000.0000 shares of capital stock having a par value of one hundred dollars (\$100)

each, all of which are entitled to vote and all of which are entitled to vote as a class.

SIXTH: The certificate of incorporation of the surviving corporation shall be the certificate of incorporation of the surviving constituent corporation without change.

SEVENTH: The merger is permitted by the laws of the State of California and is in compliance therewith.

EIGHTH: The effective date of the merger herein certified, insofar as the provisions of the New York Business Corporation Law govern such effective date, shall be the 1<sup>st</sup> day of January, 2017.
