**TRADEMARK SECURITY AGREEMENT RELEASE**

THIS TRADEMARK SECURITY AGREEMENT RELEASE (this “*Release*”) is made effective as of May 29, 2018, by Morgan Stanley Senior Funding, Inc. (“*Morgan Stanley*”), as collateral agent (in such capacity, the “*Collateral Agent*”) for the Secured Parties (as defined in the Guarantee and Collateral Agreement referred to below), in favor of Microsemi Corp. – High Performance Timing (the “*Grantor*”).

WHEREAS, the Grantor was party to that certain Guarantee and Collateral Agreement dated as of January 15, 2016 (the “*Guarantee and Collateral Agreement*”) in favor of the Collateral Agent and Morgan Stanley, as administrative agent (capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Guarantee and Collateral Agreement);

WHEREAS, pursuant to the terms of the Guarantee and Collateral Agreement, the Grantor entered into that certain Trademark Security Agreement, dated as of January 24, 2018 (the “*Trademark Security Agreement*”); and

WHEREAS, in accordance with the provisions of the Guarantee and Collateral Agreement and the Trademark Security Agreement, the Collateral Agent now desires to release its security interest in and to the Collateral (as defined below).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent hereby releases to the Grantor its security interest in all of the Grantor’s right, title and interest in and to the following (the “*Collateral*”):

- (i) all Trademarks of such Grantor, including, without limitation, the registered and applied-for Trademarks of such Grantor listed on Schedule 1 attached hereto; and
- (ii) to the extent not covered by clause (i), all Proceeds of any of the foregoing.

If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Collateral under the Trademark Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.


SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.
