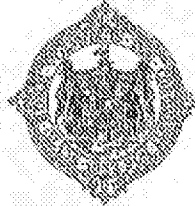


The Articles of Organization of the Company are hereby amended by deleting ARTICLE 1 in its entirety and replacing it with the following:


"(1): The name of the Limited Liability Company is:
