TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Trademark Assignment") is made and entered into this 1st day of March, 2018 (the "Effective Date"), by and among Kadion Especialidades Químicas, S.L, a limited liability company organized under the laws of Spain ("Assignee"), THE LUBRIZOL CORPORATION, a corporation organized under the laws of the State of Ohio, United States (the "Lubrizol Corporation"), and LUBRIZOL LIMITED, a company organized under the laws of England ("Lubrizol Limited," and together with the Lubrizol Corporation, the "Assignors").

RECITALS

A. Assignee and the Lubrizol Corporation are parties to an Asset Purchase Agreement effective as of the Effective Date (the "Asset Purchase Agreement"). Capitalized terms used in this Trademark Assignment, but not defined herein, have the meanings set forth in the Asset Purchase Agreement.

B. Pursuant to the Asset Purchase Agreement, the Lubrizol Corporation agreed to sell and assign, and cause its affiliates to sell and assign, their respective right, title and interest in and to the "Waxoline" trademark, which is registered in the countries set forth on Schedule I of this Trademark Assignment (the "Trademark"), and all associated goodwill.

ASSIGNMENT

1. Assignment. For value received, the receipt and sufficiency of which is hereby acknowledged, Assignors hereby sell, assign, transfer, convey and deliver to Assignee the entire right, title and interest of Assignors in, to and under the Trademark, together all goodwill associated therewith, and all rights arising out of all causes of action relating thereto after the Effective Date, including infringement of the Trademark.

2. Further Assurances. Assignors shall at any time and from time to time after the Effective Date, upon the reasonable request of Assignee, execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, all such further assignments, transfers, conveyances and assurances as may be required for assigning, transferring, conveying, assuring and confirming to Assignee the entire right, title and interest of Assignors in, to and under the Trademarks.




