10 I, Keith L. Cooper, declare as follows:

11 I am an attorney associated with de la Peña & Holiday LLP, attorneys for Communities, Inc.

12 I make this declaration based on my own personal knowledge except as to those matters stated to be
13 based on information and belief and as to those matters; I believe them to be true. I make this
14 declaration to establish ownership based on 37 C.F.R. §2.20. If called upon to do so, I could
15 competently testify to the matters contained in this declaration in a court of law.

16 1. On January 19, 2018 I filed a trademark application for the word mark
17 "Synapse."

18 2. In the application, I listed the owner as "Dynamic Communities, Inc."

19 3. This was an error on my part. Dynamic Communities, Inc. was never intended
20 to be the owner of the mark. Rather, the true owner and applicant was and is intended to be
21 "Communities, Inc."

22 4. I mistakenly and inadvertently listed Dynamic Communities, Inc. as the owner
23 when, in fact, I was supposed to have listed Communities, Inc. as the owner.

24 5. Dynamic Communities, Inc. did not and does not intend to use the Synapse
25 Trademark and, in fact, was not even aware that it was filed in their name. Communities, Inc. did
26 and does intend to use the Synapse Trademark and was expecting the trademark to be in its name.

27 6. Listing Dynamic Communities, Inc. as the owner, rather than Communities, Inc.
28 as the owner was not the mistake of the applicant, it was my mistake.


