**TRADEMARK ASSIGNMENT**

This TRADEMARK ASSIGNMENT (this “Trademark Assignment”), effective the 29<sup>th</sup> day of March 2018, is made and entered into by Get Me, LLC, a Delaware limited liability company (“Get Me”) having principle offices at 5001 Spring Valley Road, Suite 500W, Dallas, TX 75244 (“Assignor”) in favor of GMM2 LLC, a Delaware limited liability company (“GMM2”) having principle offices at 3840 Vineland Road Suite 200, Orlando, Florida 32811 (“Assignee”).

WHEREAS, Assignor owns all right, title and interest in and to trademark applications and registrations, including, without limitation, the trademark applications and registrations identified and set forth on the attached Schedule A, and any and all goodwill associated therewith (collectively, the “Marks”);

WHEREAS, Assignor and Assignee are parties to that certain Asset Contribution Agreement by and among Get Me Mears, Inc., a Delaware corporation, GMM2, Get It Holdings, LLC, a Texas limited liability company, and Get Me dated March 16, 2018 (the “Contribution Agreement”) pursuant to which Assignor has sold, and Assignee has purchased, certain assets of Assignor, including, without limitation, the Marks;

WHEREAS, Assignee is the successor to that portion of the assets of the business of Assignor to which the Marks pertain; and

WHEREAS, pursuant to the Contribution Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all right, title and interest in and to the Marks and any and all goodwill associated with the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby agrees as follows:

1. Assignor hereby irrevocably sells, conveys, assigns and transfers to Assignee, free and clear of any and all liens and encumbrances, all of Assignor’s right, title, and interest in and to the Marks, together with any and all goodwill associated therewith, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations and all corresponding rights that are or may be secured under the laws of any jurisdiction throughout the world, now or hereafter arising or in effect, for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Trademark Assignment had not been made, together with all rights to collect royalties, products and proceeds in connection with any of the foregoing and all rights to sue for past, present or future infringement, misappropriation, unfair competition, dilution or other violation of the foregoing, and all rights to recover damages or lost profits in connection therewith, and all rights corresponding thereto throughout the United States. All costs and fees in connection with recording this Trademark Assignment shall be at the sole expense of the Assignee.

2. Assignor hereby requests the Commissioner of Patents and Trademarks in the United States Patent and Trademark Office to record Assignee as the assignee and owner of the

Marks and to deliver to Assignee, and to Assignee's attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this Trademark Assignment.

3. Assignor shall provide Assignee, its successors and assigns, and their legal representatives such information, documents and assistance as reasonably necessary to effectuate the purposes of this Trademark Assignment.

4. This Trademark Assignment shall be governed by and construed in accordance with the laws of the State of New York.

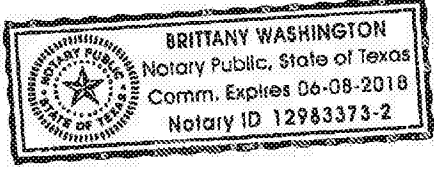


