THIRD RESOLUTION

The General Assembly, with the consent of the limited partner, and after having heard the reports by the Manager and Auditors attesting that the amount of equity is at least equal to that of the share capital, decided to transform the company into an incorporated company from this day forward.

In accordance with the provisions of article L 210-6 of the trade code, the modification to the type of company does not involve the creation of a new legal company and constitutes a simple modification of its status.

This resolution, put to the vote, is adopted by a majority of 82,593,571 votes, the cooperative Elle et Vire holding with its president 5,487,164 votes abstained and the CLHN holding 1,450,142 votes having voted against.
