**TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

**THIS TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Agreement**”), dated as of June 15, 2018, is executed by CITIBANK, N.A., in its capacity as administrative agent (the “**Administrative Agent**”) and collateral agent for the secured parties under the Guaranty and Security Agreement referred to below (the “**Secured Parties**”), in favor of DOTTIE HOLDINGS, LLC, a Delaware limited liability company (the “**Company**”). All capitalized terms used in this Agreement and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement.

**RECITALS**

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of April 24, 2018 (as amended, the “**Security Agreement**”), by and between Company and Administrative Agent, Company granted to Administrative Agent a security interest in the Collateral to secure the Company’s obligations under that certain Guaranty and Security Agreement, dated as of April 24, 2018.

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on April 25, 2018, at Reel/Frame 6344/0863, to evidence the security interest granted under the Security Agreement.

C. The Obligations secured by the Collateral have been satisfied in full and the Administrative Agent is entering into this Agreement in order to evidence the termination and release of its security interest in the Collateral.

**AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby agrees as follows:

(a) Administrative Agent expressly terminates the Security Agreement and releases its security interest in all of its right, title and interest in, to and under all of the Collateral, including, without limitation all:

(i) intellectual property listed on Exhibit A attached hereto;

(b) Administrative Agent represents and warrants that it has the full power and authority to execute this Termination.


(c) Administrative Agent agrees to execute and deliver to Company any additional documents or instruments necessary to terminate the security interests in favor of Administrative Agent in the Collateral.

(d) Administrative Agent authorizes and requests the patent and trademark divisions of the United States Patent and Trademark Office, to record this Agreement.
