RELEASE OF TRADEMARK SECURITY INTERESTS

THIS RELEASE OF TRADEMARK SECURITY INTERESTS (the “Release”) is made effective as of June 26, 2018, by Wells Fargo Bank, N.A. (“Wells Fargo”), as successor to General Electric Company (“GE”) (successor by merger to the General Electric Capital Corporation), as Collateral Agent for the Secured Parties (“Collateral Agent”), to SPTC, Inc. (“SPTC”) and such additional Sotheby Entities as defined in the Credit Agreement (together with SPTC, each such Person individually referred to herein as “Grantor” and collectively the “Grantors”) as follows (capitalized terms used herein without definition are used as defined in the Security Agreement):

WHEREAS, the Grantors and the Collateral Agent are parties to that certain Amended and Restated Guaranty and Security Agreement dated as of August 22, 2014, (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, SPTC was required to execute and deliver to the Collateral Agent (i) that certain Intellectual Property Security Agreement dated as of February 13, 2014 and recorded with the United States Patent and Trademark Office on February 14, 2014 at Reel 5217, Frame 0381, and (ii) that certain Intellectual Property Security Agreement dated as of June 15, 2015 and recorded with the United States Patent and Trademark Office on June 15, 2015 at Reel 5552, Frame 0926 ((i) and (ii) together, the “Original Trademark Agreements”, and as amended by the Assignment of Original Trademark Agreements, the “Trademark Agreements”), as assigned and transferred by the Assignment of Intellectual Property Security Agreements dated August 15, 2016 between GE and Wells Fargo and recorded with the United States Patent and Trademark Office on September 21, 2016 at Reel 5880, Frame 0719 (the “Assignment of Original Trademark Agreements”), in order to secure the prompt and complete payment, observance and performance of all of the Secured Obligations in accordance with the terms and conditions of the various loan documents;

WHEREAS, pursuant to the Trademark Agreements, SPTC granted to the Collateral Agent, among other collateral, a Lien (as defined in the Trademark Agreements) on and continuing security interest in all of SPTC’s right, title and interest, in, to and under the Trademark Collateral (as defined in the Trademark Agreements), including the Trademarks (as defined in the Trademark Agreements) listed on the attached Schedule A (the “Total Trademark Collateral”);

WHEREAS, the Collateral Agent wishes to release, terminate, cancel, relinquish and discharge its Lien on and continuing security interest and all other rights it may have in, to or under the Total Trademark Collateral and retransfer and reassign to SPTC without recourse all of the Collateral Agent’s right, title and interest (if any) in, including goodwill, to or under the Total Trademark Collateral.

NOW THEREFORE, as the Grantors have satisfied their Secured Obligations under the Security Agreement, the Collateral Agent hereby releases, terminates, cancels, relinquishes and discharges any Lien on and continuing security interest and all other rights it may have in, to or under the Total Trademark Collateral, and assigns, transfers, and conveys to SPTC any and all

right, title and interest (if any) in, including goodwill, to, or under the Total Trademark Collateral that the Collateral Agent may hold. The Collateral Agent hereby agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect such release, termination, cancellation, relinquishment and discharge of its Lien on and continuing security interest and all other rights it may have in, to or under the Total Trademark Collateral as contemplated hereby, in each case at no cost or liability to the Collateral Agent.
