## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this “**Agreement**”) is made as of June 12, 2018, (the “**Effective Date**”), by and between Carmella Barrett-Perry, DDS, P.C., an Illinois professional corporation, (the “**Assignor**”), and United Dental Partners, LLC, an Illinois limited liability company, (the “**Assignee**”).

### RECITALS

**WHEREAS**, Assignor is the registered owner of a mark that is registered in the United States Patent and Trademark Office, Registration No. 3784609, dated May 4, 2010 (the “**Mark**”).

**WHEREAS**, Assignee acquired substantially all of the assets of Assignor pursuant to that certain Asset Purchase Agreement dated June 4, 2018 by and among Assignor, Carmella Barrett-Perry, D.D.S., Assignee and All Kids Dental Center, LLC, an Illinois limited liability company (the “**Asset Purchase Agreement**”).

**WHEREAS**, pursuant to the Asset Purchase Agreement, Assignee wishes to acquire all of Assignor’s rights in the Mark as listed in this Agreement.

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

### AGREEMENT

1. The Assignor hereby conveys, transfers, and assigns to the Assignee all of the Assignor’s right, title, and interest of whatever kind in the Mark, together with:

- a. the goodwill of the business relating to the products and services on which the Mark is used and for which the Mark is registered;
- b. all income, royalties, and damages hereafter due or payable to Assignor with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark; and
- c. all rights to sue for past, present and future infringement or misappropriations of the Mark.

2. The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Mark and its related property. Assignee shall pay any fees required to secure, complete, or vest the Assignee with full right, title, and interest in the Mark.
