RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of June 27, 2018, by M&T Bank, a New York banking corporation, as Secured Party (the “**Secured Party**”) in favor of Conning, Inc., a Missouri corporation, with an address at One Financial Plaza, Hartford, Connecticut 06103 (the “**Grantor**”).

WITNESSETH:

WHEREAS, Secured Party and Grantor were parties to that certain Security Agreement, dated as of February 27, 2013 (the “**Security Agreement**”), pursuant to which Grantor granted a security interest to Secured Party in, inter alia certain trademark registrations and applications, and the goodwill associated therewith, set forth on Exhibit A attached hereto and made a part hereof (those trademark registrations and applications listed on Exhibit A are collectively referred to as the “**Trademarks**” for the purposes of this document); and

WHEREAS, Secured Party recorded a security interest in said Trademarks with the Assignment Division of the United States Patent and Trademark Office on March 4, 2013 at Reel 4982, Frame 0603.


NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in the Trademarks originally granted to Secured Party pursuant to the Security Agreement.
2. Secured Party, to the extent granted in the Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, all of its right, title and interest in and to the Trademarks and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreement.
3. Upon the request of Grantor, Secured Party further agrees to execute all documents necessary to demonstrate and confirm the parties’ intent under this Release of Trademark Security Interest.
