TRADEMARK ASSIGNMENT

This Trademark Assignment (“Assignment”) is made **January 4, 2018** (“Effective Date”) from **Caribbean Coffee Company, Inc.**, a California corporation (“ASSIGNOR”) to **Bona Fide Brewing Company, LLC**, a Delaware limited liability company (“ASSIGNEE”).

WHEREAS, ASSIGNOR owns the rights to the trademark “**BONA FIDE**” (“Mark”) including all rights to U.S. Trademark Registration No. **4842977**, together with the goodwill of the business symbolized thereby in connection with all the Goods and/or Services on which the Mark has been used by ASSIGNOR (“Goods/Services”); and


WHEREAS, ASSIGNOR desires to quitclaim, convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby quitclaims, conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Mark in perpetuity, together with (1) the goodwill of the business relating to the Goods/Services in respect upon which the Mark is and has been used; (2) all income, fees, payments, royalties, and damages now or hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Mark.

ASSIGNOR further covenants that it will execute all reasonably necessary documents, papers, forms, and authorizations and take all other reasonably necessary actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark. ASSIGNOR further appoints ASSIGNEE, with the full power of substitution therein, as its true and lawful attorney-in-fact for the limited purpose of executing such papers and performing such other proper acts as may be reasonably necessary to secure to ASSIGNEE, or to its successors or assigns, the rights hereby transferred.

IN WITNESS WHEREOF, ASSIGNOR has duly executed and delivered this Assignment, as of the Effective Date.
