CORRECTIVE TRADEMARK ASSIGNMENT

WHEREAS, Assignor warrants that it owns all rights, title and interest of every kind, nature or description in and to the Marks, all rights therein, including any and all past, present and future registrations and applications therefor, all rights of renewal thereof, all rights to royalties for the licensing thereof, all claims for infringement thereof, and all goodwill pertaining thereto (hereinafter "All Rights in the Marks"); and

WHEREAS, Assignor desires to assign to Assignee Quady South Winery, LLC, a California limited liability company having a current business address of 13181 Road 24, Madera, California 93637, USA (hereinafter "Assignee"), All Rights in the Marks (as defined hereinabove); and

WHEREAS, Assignee is desirous of acquiring All Rights in the Marks;


NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby sell, assign, set over and transfer to Assignee All Rights in the Marks (as defined hereinabove), *nunc pro tunc* effective December 24, 2012. This assignment of all claims for damages by reason of past infringement(s) of the Marks, includes the right of Assignee to sue for and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives. These assigned rights shall be held and enjoyed by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns and other legal representatives, at common law and/or to the end of the term or terms of which registrations pertaining to the Marks may be granted, or renewed, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made.

Assignor agrees to execute all documents necessary to effectuate and maintain registrations pertaining to the Marks, now and in the future.

The undersigned officers of Assignor and Assignee each represent that he/she has authority to execute this Assignment on behalf of the party, and to carry out all obligations imposed hereunder. The undersigned have read, understand, and agree to the terms of this Assignment.
