Whereas, Ergo Depot, LLC, a Louisiana limited liability company, ("ASSIGNOR") has owned U.S. Patent and Trademark Office Registration Nos. 4,496,516 and 5,063,223 for the mark JARVIS (the Mark and Registrations); and
