TRADEMARK ASSIGNMENT

As of the Effective Date, the Assignor does hereby, sell, assign, transfer and set over to Assignee all of its right, title and interest in and to the Trademark and the goodwill of the business connected with and symbolized by the Trademark including, all rights to renew and extend the Trademark, all common law and statutory rights related thereto, all rights to sue and recover damages and profits and obtain such other legal or equitable relief available for all past, present and future infringements thereof.
- 2. The Assignor authorizes the United States Patent and Trademark Office to record the transfer of the registration of the Trademark to Assignee as recipient of Assignor's right, titled and interest therein.
- 3. This Assignment is governed by and is to be construed in accordance with the laws of the State of Minnesota.
- 4. This Assignment is the entire agreement with respect to the Trademark and supersedes any oral negotiations or prior written agreements, other than the Agreement, with respect to the Trademark.
