**TERMINATION OF SECURITY INTERESTS IN  
TRADEMARKS AND SERVICE MARKS**

This Termination of Security Interests in Trademarks and Service Marks (this "Agreement") is made effective as of the ~~30~~<sup>31</sup> day of April 2018, by TD Bank, N.A., a banking association with an office in Burlington, Vermont (the "Bank"), and Rome Snowboards Corporation, a Delaware corporation as borrower (the "Borrower").

WHEREAS, the Borrower assigned to the Bank, as collateral security, a security interest in all Borrower's right, title and interest in and to certain trademarks and service marks identified on *Exhibit A* (the "Marks") to the Bank to secure obligations under a Business Loan Agreement, dated as of July 27, 2006 and subsequently amended and supplemented;

WHEREAS, the Bank has agreed to terminate its security interests in the Marks and quitclaim such security interests back to the Borrower.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, and intending to be legally bound hereby, the parties agree as follows:

The Bank hereby terminates its security interests in the Marks. The Bank hereby quitclaims and assigns to the Borrower all interests held by the Bank in the Marks, together with the goodwill symbolized thereby. The Borrower hereby accepts such assignment and acknowledges such assignment is without representation or warranty or liability on the part of the Bank.
