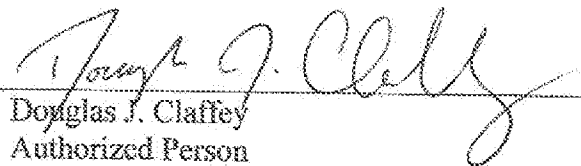
1. The name of the limited liability company is WorkplaceDynamics LLC.
