
TRADEMARK ASSIGNMENT

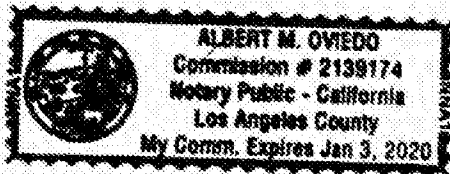


