RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**"), dated as of June 1, 2018, is made by **CORTLAND CAPITAL MARKET SERVICES LLC**, as Agent ("**Agent**"), having an office at 225 W. Washington Street, 9th Floor, Chicago, Illinois 60606.

WHEREAS, Willbros T&D Services, LLC, a Delaware limited liability company (as successor in interest to Trafford Corporation) ("**T&D**"), Willbros Group, Inc., a Delaware corporation ("**Parent**", and together with T&D, the "**Grantors**" and each a "**Grantor**"), JPMorgan Chase Bank, N.A. ("**JPM**") and certain other parties are party to that certain Grant of Security Interest in Trademark Rights dated December 15, 2014, recorded on December 16, 2014, in the United States Patent and Trademark Office commencing at Reel No. 5419, Frame No. 0936 (the "**Original Trademark Agreement**");

WHEREAS, JPM and Agent are parties to that certain Assignment of Security Interest in Trademark Collateral dated February 4, 2016, recorded on February 9, 2016, in the United States Patent and Trademark Office commencing at Reel No. 5726, Frame No. 0927 (the "**Assignment**", and together with the Original Trademark Agreement, the "**Agreements**");

WHEREAS, the Agreements granted to the Agent a security interest in all of each Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement), including, without limitation, all of such Grantor's right, title and interest in, to and under the Trademark Collateral listed on the Schedule attached to each Agreement (including the Trademark Collateral attached hereto and made a part hereof as an Annex) (together, the "**Total Trademark Collateral**"); and

WHEREAS, Agent now desires to release, terminate, cancel, relinquish and discharge its continuing security interests granted in each of the Agreements in the Total Trademark Collateral and hereby authorizes and requests the United States Patent and Trademark Office to record this Release against the Total Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby releases, terminates, cancels, relinquishes and discharges (i) its continuing security interest and all other rights in, to and under the Total Trademark Collateral (including all goodwill of the business connected with the use of, and symbolized by, each of the Total Trademark Collateral) and (ii) each Agreement and any and all other rights it may have under the same, and hereby reassigns without recourse or warranty to the Grantors any and all such right, title and interest (if any) that the Agent may have in, to and under the Total Trademark Collateral.




