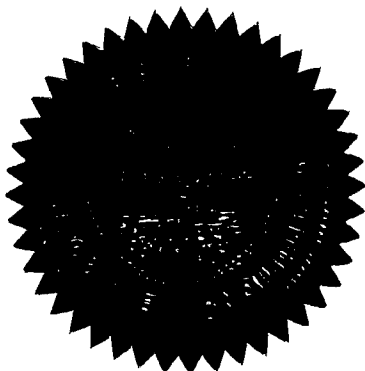

**ARTICLES OF MERGER OF
CIVIC BANK & TRUST (CONTROL NO. 493037)**

INTO

FRANKLIN SYNERGY BANK (CONTROL NO. 550755)

Pursuant to the provisions of Sections 45-2-1301 et seq. and 48-21-101 et seq. of the Tennessee Code Annotated, the undersigned corporations adopt the following articles of merger for the purpose of merging into a single corporation:

1. The Agreement and Plan of Reorganization and Bank Merger dated December 14, 2015, as amended by Amendment No. 1 thereto dated May 9, 2016, Amendment No. 2 thereto dated March 30, 2017, and Amendment No. 3 thereto dated September 29, 2017 (the "Merger Agreement"), was approved by each of the undersigned corporations in the manner prescribed by the Tennessee Business Corporation Act and the Tennessee Banking Act.
2. As to Franklin Synergy Bank, the Merger Agreement was duly approved by its sole shareholder on December 14, 2015.
3. As to Civic Bank & Trust, the Merger Agreement was duly adopted at a meeting of the shareholders on March 30, 2018.
4. These Articles of Merger shall be effective as of 12:01 A.M. on April 1, 2018 (the "Effective Time").


