**TERMINATION OF GRANT OF A SECURITY INTEREST -- TRADEMARKS

The Grantee agrees to provide Grantor with any information and additional authorization and documentation necessary to effect the release of the Grantee's security interest in the Collateral (without recourse, representation or warranty and at Grantor's sole cost and expense).
