**TERMINATION AND RELEASE OF  
SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Second Lien Security Interest in Trademarks (“Release”) is made as of July 19, 2018, by **SUNTRUST BANK**, a Georgia banking corporation (“Administrative Agent”) in favor of **ACCESSLINE COMMUNICATIONS CORPORATION**, and **INTERMEDIA.NET, INC.**, each a Delaware corporation with an address at 825 E. Middlefield Road, Mountain View, California 94043 (collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into a Second Lien Trademark Security Agreement dated February 1, 2017 with the Administrative Agent, notice of which was recorded on February 1, 2017 at the United States Patent and Trademark Office at Reel 5979, Frame 0793 and Reel 5979, Frame 0546.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Second Lien Trademark Security Agreement.

WHEREAS, Grantors granted the Administrative Agent, under the terms of the Second Lien Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of their right, title and interest in their Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, including the goodwill connected with the use of and symbolized thereby, and assigns, transfers and conveys to Grantor the Security Interest without recourse, representation or warranty.
