**TRADEMARK ASSIGNMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee, all right, title and interest in and to the Assigned Trademarks, together with the goodwill associated therewith, and including the right to sue for past infringement and the right to further transfer and assign the Assigned Trademarks without further remuneration or consideration to Assignor. Assignor further agrees to provide reasonable assistance to Assignee to effectuate this Trademark Assignment, including by providing any additional documentation helpful in recording the transfer of the Assigned Trademarks. Assignee will be solely responsible for bearing the costs and fees, if any, incurred in recording or otherwise perfecting the conveyance of the Assigned Trademarks under this Trademark Assignment.

This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties and their respective officers, affiliates, personal and legal representatives, heirs, successors and assigns.

This Assignment shall be governed by the law of the State of Oklahoma.

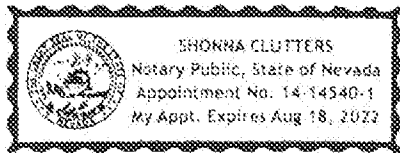


