"The name of this corporation is ClientPoint, Inc."

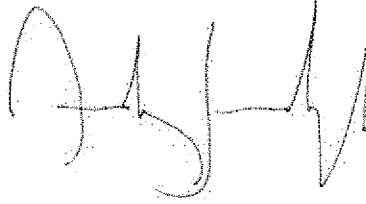
