
To have and to hold, to said Grantee, its heirs, executors, administrators, successors and assigns forever.



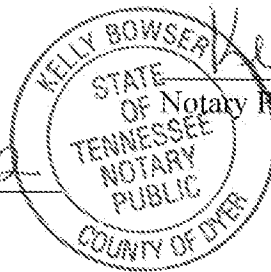

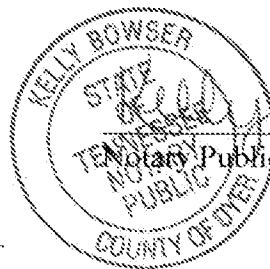
