**TERMINATION AND RELEASE
OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS) (this "Release"), dated as of September 12, 2018, by **JPMORGAN CHASE BANK, N.A.**, (the "Lender"), in favor of **iCIMS, INC.**, a New Jersey corporation (the "Grantor").

WHEREAS, pursuant to the terms of that certain Pledge and Security Agreement, dated as of May 26, 2017 (as amended supplement or otherwise modified from time to time, the "Security Agreement"), among the Grantor, the other parties thereto and the Lender, and that certain Grant of Security Interest (Trademarks) (the "Trademark Security Agreement"), dated as of May 26, 2017, between the Grantor and the Lender, the Grantor granted to the Lender a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule A attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (together with the Trademarks, the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement);

WHEREAS, the Lender wishes to terminate and release its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, including the Trademarks identified on Schedule A attached hereto; and


WHEREAS, the Trademark Security Agreement was filed on May 30, 2017 with the United States Patent and Trademark Office in Reel: 6072; Frame: 0372.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, as granted under the Security Agreement and the Trademark Security Agreement, and reassigns and transfers to the Grantor all right, title and interest that the Lender may have in the Collateral, and terminates the Trademark Security Agreement. The Lender hereby authorizes the Grantor, or the Grantor's authorized representative or designee, to record this Release with the United States Patent and Trademark Office.
