

ARTICLES OF ORGANIZATION

FULLY LLC

ARTICLE 1

The name of the Company is Fully LLC.

ARTICLE 2

The Company's duration will be perpetual.

ARTICLE 3

The Company is a benefit company subject to ORS 60.750-60.770.

ARTICLE 4

ARTICLE 10

A. The Company will indemnify to the fullest extent permitted by law any person who is made or threatened to be made a party to, witness in, or otherwise involved in, any action, suit or proceeding (a "Claim"), whether civil, criminal, administrative, investigative or otherwise (including an action, suit or proceeding by or in the right of the Company), by reason of the fact that the person (an "Indemnified Person") is or was a member or manager of the Company, or a fiduciary within the meaning of the Employee Retirement Income Security Act of 1974 with respect to any employee benefit plan of the Company, or serves or served at the request of the Company as a director, manager, officer, employee or agent or as a fiduciary of an employee benefit plan, of another limited liability company, corporation, partnership, joint venture, trust or other enterprise. The Company will advance to or pay on behalf of an Indemnified Person expenses (including attorney fees and disbursements) incurred or to be incurred by the Indemnified Person in defending a Claim to the fullest extent permitted by law; provided, however, the Company may recover from an Indemnified Person any advance or payment if it is subsequently determined by a court decision from which no appeal may be taken that the Indemnified Person was not entitled to be indemnified with respect to the Claim. Any indemnification provided pursuant to this Article 10 will not be exclusive of any rights to which the Indemnified Person may otherwise be entitled under any provision of these Articles of Organization, or under any operating agreement, other agreement, statute, policy of insurance, vote of members or managers, or otherwise.

B. To the fullest extent permitted by law, no Indemnified Person will be personally liable to the Company or its members for damages by reason of any act or omission performed or omitted which the Indemnified Person believed to be in the interests of the Company.

C. If Oregon statutes are amended after these Articles of Organization are filed with the Secretary of State expanding the conditions under which the Company may indemnify an Indemnified Person or authorizing action further eliminating or limiting the personal liability of any Indemnified Persons, the statutes, as amended, will apply to the obligations of the Company and the rights of the Indemnified Persons under this Article 10. No (a) amendment or repeal of this Article 10 by the Company, (b) amendment of these Articles of Organization inconsistent with this Article 10 or (c) change in Oregon statutes, will diminish the obligations of the Company or the rights of the Indemnified Persons under this Article 10 with respect to a Claim which arose in whole or in part before the effective date of the amendment or repeal of this Article 10 or these Articles of Organization or the change in Oregon statutes.
