TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of August 2, 2018, by NXT CAPITAL, LLC, as administrative agent ("Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Vector Laboratories, Inc., a California corporation ("Vector"), TriLink BioTechnologies, LLC, a Delaware limited liability company ("TriLink", together with Vector, collectively, the "Grantors", and each individually, a "Grantor") and Agent are parties to a Trademark Security Agreement dated as of September 15, 2016 (the "Security Agreement"), pursuant to which Grantors granted a security interest to Agent for the benefit of the Secured Parties, in the Trademark Collateral as security for certain obligations owing by Grantors to the Secured Parties including certain trademarks (the "Trademarks") set forth on Schedule A hereto; and

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on February 16, 2017 at Reel 5990, Frame 0507; and

WHEREAS, Grantors have requested that Agent release its security interest in the Trademarks and Trademark Collateral and reassign the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby terminates, discharges and releases all of its security interest in all of Grantors' right, title and interest in and to the Trademark Collateral, including the Trademarks set forth on Schedule A, and hereby terminates the Security Agreement.


2. Agent hereby reassigns, grants and conveys to Grantors, without any representation, recourse, warranty or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral and the Trademarks.

3. Agent agrees to take all further actions, and provide to Grantors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors, at Grantors' sole cost and expense, to more fully and effectively effectuate the purposes hereunder.
