1. We are the Head of Legal and Attorney at Law (Germany) of Faber-Castell Aktiengesellschaft, a corporation organized and existing under the laws of Germany, are over eighteen years of age and are fully competent to make this Declaration, which is based on our personal knowledge of the facts stated herein.




2. The term "AG" is a commonly used abbreviation for the term "Aktiengesellschaft."

3. Although the records of the United States Patent and Trademark Office (USPTO) identify the owner of U.S. Registration Nos. 1056171, 2060468, 2313780, and 3371890 as "Faber-Castell AG," the true owner is Faber-Castell Aktiengesellschaft. The application that matured into U.S. Registration No. 3371890 and the assignment documents recorded against U.S. Registration Nos. 1056171, 2060468, and 2313780 unfortunately reflect a minor clerical error that resulted in the term "Aktiengesellschaft" being abbreviated as "AG." Counsel of record for these four registrations has been instructed to seek a correction of the records of the USPTO as to the owner's correct name as soon as practicable.

4. Although the records of the USPTO identify the owner of U.S. Registration Nos. 3590415 and 3590416 as "A.W. Faber-Castell Unternehmensverwaltung & Co.," the true owner is "A.W. Faber-Castell Unternehmensverwaltung GmbH". The applications that matured into these registrations unfortunately reflect a minor clerical error that resulted in the incorrect term "& Co." being substituted for the correct term "GmbH" Counsel of record for these two registrations has been instructed to seek a correction of the records of the USPTO as to the owner's correct name as soon as practicable.

5. The true owner of U.S. Registration Nos. 3590415 and 3590416, the A.W. Faber-Castell Unternehmensverwaltung GmbH, is the parent entity, holding 100 percent the shares, of the Faber-Castell Aktiengesellschaft, Applicant for U.S. Serial No. 87313284.




