**RELEASE OF SECURITY INTEREST IN TRADEMARKS
(REEL/FRAME 6382/0356)**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of September 18, 2018 (the “Effective Date”), is made by SunTrust Bank, in its capacity as Administrative Agent (the “Agent”), in favor of each grantor party identified on the signature page hereto (collectively, the “Grantors”).

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of May 7, 2018, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Administrative Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, each Grantor executed and delivered a Notice of Grant of Security Interest in Trademarks, dated as of May 7, 2018 (the “Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 9, 2018 at Reel/Frame 6382/0356; and

WHEREAS, the Grantors have fulfilled all Secured Obligations (as defined in the Security Agreement), and the Agent agrees to release the grant of its lien on and security interest in and to all of the right, title, and interest of the Grantors in the Trademark Collateral (as defined herein), and to reconvey any and all rights in the Trademark Collateral to the Grantors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the trademarks and trademark applications set forth Schedule 1 attached hereto (the “Trademark Collateral”) arising under the Security Agreement and the Trademark Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.


4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Agent hereby authorizes the Grantors, or the Grantors’ authorized representatives to record this Release with the United States Patent and Trademark Office

and/or any other applicable governmental office or agency in order to memorialize the release of the lien on and security interest of the Trademark Collateral.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.





