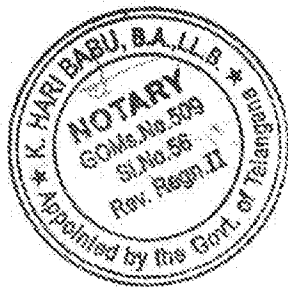
CONFIRMATORY TRADEMARK ASSIGNMENT

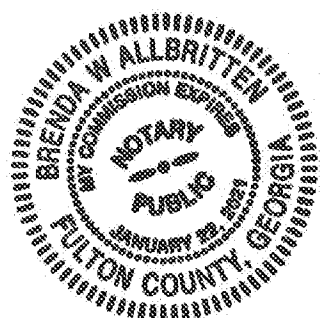

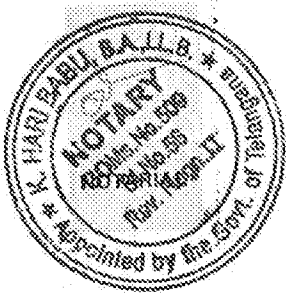
