CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment is by and between Brew Dr. Holdings, LLC ("BDH"), an Oregon limited liability company with Oregon Registry Number 719978-95, The Townshend Group LLC ("TTG"), an Oregon limited liability company with Oregon Registry Number 1165588-91, and Brew Dr. Kombucha, LLC ("BDK"), an Oregon limited liability company with Oregon Registry Number 1182152-92, collectively the Parties. This Confirmatory Trademark Assignment shall have an effective date of February 12, 2016.

WHEREAS, BDH was formerly named Brew Dr. Kombucha, LLC but is a distinct entity from BDK.

WHEREAS, BDK was formerly named New BDK, LLC.

WHEREAS, on February 12, 2016, BDH and TTG entered into an Admission and Contribution Agreement ("the ACA"), attached hereto as Exhibit A and incorporated herein, and an Assignment and Assumption Agreement ("the BDH-to-TTG-AAA"), attached hereto as Exhibit B and incorporated herein, collectively in which BDH assigned to TTG all of BDH's then assets and liabilities other than as relating to one identified contract.

WHEREAS, subsequently on February 12, 2016, TTG and BDK entered into a Subscription and Contribution Agreement ("the SCA"), attached hereto as Exhibit C and incorporated herein, and an Assignment and Assumption Agreement ("the TTG-to-BDK-AAA"), attached hereto as Exhibit D and incorporated herein, collectively in which TTG assigned to BDK the assets and liabilities acquired from BDH by way of the ACA and the BDH-to-TTG-AAA.

WHEREAS, the ACA, the BDH-to-TTG-AAA, the SCA, and the TTG-to-BDK-AAA are collectively referred to as "the Closing Documents."

WHEREAS, pursuant to the Further Acts provisions of the Closing Documents, BDK requests that the Parties execute this Confirmatory Trademark Assignment to confirm that BDK owns all trademarks owned by BDH as of February 12, 2016, together with the corresponding goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

BDK (formerly New BDK, LLC) owns and shall own the entire right, title, and interest to the various marks owned and used by BDH (formerly Brew Dr. Kombucha, LLC) as of February 12, 2016, including (but not limited to) the marks identified in the attached Schedule of Registered Marks, as well as stylized versions and variations thereof, together with the corresponding goodwill of BDH (formerly Brew Dr. Kombucha, LLC) connected with the use of and symbolized by the marks, as well as to the corresponding U.S. trademark and service mark registrations identified in the Schedule of Registered Marks.

To the extent necessary, BDH (formerly Brew Dr. Kombucha, LLC) and TTG hereby individually and collectively assign and agree to assign to BDK (formerly New BDK, LLC) the entire right, title, and interest to the various marks owned and used by BDH as of February 12, 2016, including (but not limited to) the marks identified in the attached Schedule of Registered Marks, as well as stylized versions and variations thereof, together with the corresponding goodwill of BDH (formerly Brew Dr. Kombucha, LLC) connected with the use of and symbolized by the marks, as well as to the corresponding U.S. trademark and service mark registrations identified in the Schedule of Registered Marks.
