**CONFIRMATORY TRADEMARK ASSIGNMENT**

This Confirmatory Trademark Assignment is by and between Cascadia Tea Holdings, LLC ("CTH"), an Oregon limited liability company with Oregon Registry Number 362550-99, The Townshend Group LLC ("TTG"), an Oregon limited liability company with Oregon Registry Number 1165588-91, and Cascadia Tea Company, LLC ("CTC"), an Oregon limited liability company with Oregon Registry Number 1182154-90, collectively the Parties. This confirmatory Trademark Assignment shall have an effective date of February 12, 2016.

WHEREAS, CTH was formerly named Cascadia Tea Company, LLC but is a distinct entity from CTC.

WHEREAS, CTC was formerly named New CTC, LLC.

WHEREAS, on February 12, 2016, CTH and TTG entered into an Admission and Contribution Agreement ("the CTH-ACA"), attached hereto as Exhibit A and incorporated herein, and an Assignment and Assumption Agreement ("the CTH-to-TTG-AAA"), attached hereto as Exhibit B and incorporated herein, collectively in which CTH assigned to TTG all of CTH's then assets and liabilities.

WHEREAS, subsequently on February 12, 2016, TTG and CTC entered into a Subscription and Contribution Agreement ("the TTG-CTC-SCA"), attached hereto as Exhibit C and incorporated herein, and an Assignment and Assumption Agreement ("the TTG-to-CTC-AAA"), attached hereto as Exhibit D and incorporated herein, collectively in which TTG assigned to CTC the assets and liabilities acquired from CTH by way of the CTH-ACA and the CTH-to-TTG-AAA.

WHEREAS, the CTH-ACA, the CTH-to-TTG-AAA, the TTG-CTC-SCA, and the TTG-to-CTC-AAA are collectively referred to herein as "the Closing Documents."

WHEREAS, pursuant to the Further Acts provisions of the Closing Documents, CTC requests that the Parties execute this Confirmatory Trademark Assignment to confirm that CTC owns all trademarks owned by CTH as of February 12, 2016, together with the corresponding goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

CTC (formerly New CTC, LLC) owns and shall own the entire right, title, and interest to the various marks owned and used by CTH (formerly Cascadia Tea Company, LLC) as of February 12, 2016, including (but not limited to) the marks identified in the attached Schedule of Registered Marks, as well as stylized versions and variations thereof, together with the corresponding goodwill of CTH (formerly Cascadia Tea Company, LLC) connected with the use of and symbolized by the marks, as well as to the corresponding U.S. trademark and service mark registrations identified in the Schedule of Registered Marks.

To the extent necessary, CTH (formerly Cascadia Tea Company, LLC) and TTG hereby individually and collectively assign and agree to assign to CTC (formerly New CTC, LLC) the entire right, title, and interest to the various marks owned and used by CTH as of February 12, 2016, including (but not limited to) the marks identified in the attached Schedule of Registered Marks, as well as stylized versions and variations thereof, together with the corresponding goodwill of CTH (formerly Cascadia Tea Company, LLC) connected with the use of and symbolized by the marks, as well as to the corresponding U.S. trademark and service mark registrations identified in the Schedule of Registered Marks.
