SHORT-FORM TRADEMARKS SECURITY AGREEMENT

WHEREAS, each of LEAPFORCE, INC., a California corporation and RATERLABS, INC., a California corporation (each a "Grantor") has adopted, used, is using, or intends to use, and is the owner of the trademarks and trademark applications listed in the attached Schedule of Registered Trademarks and Trademark Applications, and the registrations and applications associated therewith;


WHEREAS, each Grantor has executed that certain General Security Agreement – Target Group dated as of 7 December 2017 (as modified from time to time, the "Security Agreement") among the Grantors and Appen Butler Hill Inc., as grantors and The Bank of New York Mellon, in its capacity as security trustee, as Secured Party (as defined in the Security Agreement), in which each Grantor has granted certain interests in favor of the Secured Party for the benefit of the Secured Creditors (as so defined); and

WHEREAS, pursuant to the Security Agreement, the Grantors have agreed with the Secured Party to execute this Short-Form Trademarks Security Agreement;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby grants to the Secured Party for the benefit of the Secured Creditors, to the extent provided in the Security Agreement (the terms and conditions of which are hereby incorporated herein), a security interest in all of its right, title and interest in, to and under all the trademarks, whether now owned or at any time hereafter acquired, of such Grantor that are registered with, or for which applications for registration have been filed with, the United States Patent and Trademark Office, including the trademarks listed on the attached Schedule of Registered Trademarks and Trademark Applications, and all registrations and pending applications associated therewith (excluding any application for registration of a trademark filed on an intent-to-use basis solely to the extent that the grant of a security interest in any such trademark application would materially adversely affect the validity or enforceability of the resulting trademark registration or result in cancellation of such trademark application), as collateral security for the prompt and complete payment and performance when due of all the Secured Obligations (as defined in the Security Agreement). Notwithstanding the foregoing, in the event of any conflict between this Short-Form Trademarks Security Agreement and the Security Agreement, the Security Agreement shall control.
