RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of October 1, 2018, by COMERICA BANK, a Texas banking association ("Lender") in favor of SPREDFAST, INC., a Delaware corporation ("Grantor") with its principal place of business located at 200 W. Cesar Chavez Street, Suite 600, Austin, TX 78701-3819.

Recital

WHEREAS Grantor granted to Lender a security interest in certain Copyrights, Trademarks, and Patents, including without limitation the Trademarks described on Exhibit A attached hereto; all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits); the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world; and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof (the "Intellectual Property"), under an Amended and Restated Intellectual Property Security Agreement dated as of August 25, 2014, as amended from time to time (the "Security Agreement"), and recorded with the US Patent and Trademark Office as set forth on Exhibit A.

WHEREAS Grantor has no outstanding obligations to Lender under the terms of the Security Agreement, Grantor has requested that Lender release its security interests in all right, title and interest of the Lender in and to the Intellectual Property and Lender agrees to release its security interest in the Intellectual Property.

Agreement

Now therefore, Lender hereby terminates the Security Agreement and terminates and releases its security interest in, to and under the Intellectual Property and reassigns to Grantor, without warranty or recourse, all right, title and interest of Lender in the Intellectual Property.

Lender shall, at Grantor's sole expense, take such further actions and provide to Grantor cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), in each case as reasonably requested by Grantor to effectuate the purposes of this Release.
