

ASSIGNORS covenant and agree that ASSIGNORS have the full right to convey the interest assigned, and that ASSIGNORS have not executed, and will not execute, any agreement in conflict, and will cooperate with ASSIGNEE to execute all lawful papers and rightful oaths or declarations to assist in protecting the Marks.




