RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "**Release**") dated as of October 2, 2018 between MWH Global, Inc. (the "**Grantor**"), and Canadian Imperial Bank of Commerce, as administrative agent for the Secured Parties (in such capacity, the "**Administrative Agent**").

RECITALS

- (A) Pursuant to a Notice of Grant of Security Interests in Trademarks, dated as of May 6, 2016 (the "**Agreement**"; capitalized terms used but not otherwise defined herein have the meanings specified in the Agreement) between the Grantor and the Administrative Agent, which Agreement was recorded in the US Trademark Office on May 6, 2016, at Reel 5788, Frame 0992, the Grantor has granted a security interest in its right, title and interest in the Intellectual Property Collateral to the Administrative Agent, for the benefit of the Secured Parties.
- (B) The Administrative Agent (acting on behalf of the Secured Parties) has agreed to release the security interests created under the Agreement in the Intellectual Property Collateral, which is listed in Schedule 1, on the terms and conditions set forth in the Global Release of Security dated as of October 2, 2018, among the Administrative Agent, the Grantor and certain other parties thereto.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent (acting on behalf of the Secured Parties) hereby releases the security interests over the Intellectual Property Collateral created by the Agreement as of the date first written above.


