**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this “Release”) is made this 6<sup>th</sup> day of September, 2018, by BMO Harris Bank, N.A., as lender (“Lender”).

**WHEREAS**, reference is made to a certain Intellectual Property Security Agreement dated as of January 17, 2017 and recorded with the United States Patent and Trademark Office on January 17, 2017, at Reel 5968 Frame 0732 (as amended, restated, amended and restated, supplemented and/or modified to date, the “IP Security Agreement”), by Florida Food Products, LLC, a Florida limited liability company, Florida Food Holding Corp., a Delaware corporation, and FFP Export, Inc., a Delaware corporation, (individually, each a “Grantor” and collectively, the “Grantors”) in favor of Lender. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the IP Security Agreement.

**WHEREAS**, under the IP Security Agreement, each Grantor granted to Lender a continuing security interest in all of the right, title and interest of such Grantor in and to the Intellectual Property Collateral identified therein, including, but not limited to, the Trademarks set forth on Schedule A attached hereto.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) terminates the IP Security Agreement, (ii) releases any and all liens on, and its security interest in and to the Intellectual Property Collateral arising under the IP Security Agreement, including, but not limited to, the Trademarks set forth on Schedule A attached hereto, and (iii) authorizes the recordation of this Release by Grantors or their designee with the United States Patent and Trademark Office.


This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
